To whom it may concern:

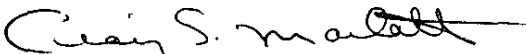
I spoke with your office several times earlier this month pertaining to the inactive status of our organization. I was initially told that it was your mistake and then told it was our mistake because we did not file the Annual Report (which we did. See enclosed check copy). After I explained that, I was told that we had indeed filed but had not given the Federal E.I.N. when we filed and that if I would do that we would be fine. I was then informed that we were notified about the E.I.N. but apparently we did not receive that notification due to an address change.

In response I immediately emailed the current updated address information with the E.I.N. and got a response on Oct. 21st saying we had been dissolved and it would now cost us over \$900 to reinstate the corporation.

I called your office again yesterday and they told me since we didn't get the letter about the E.I.N. mishap we would not have to pay anything to get reinstated but that I should send the information that I am now sending to you and it would be taken care of with no additional cost to us.
