Article of Incorporation For International Zion Church of God Pentecostal, Inc.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, (Not for profit) adopts the following Articles of Incorporation of such corporation:

Article I: Name

The name of the corporation shall be International Zion Church of God Pentecostal Inc.

Article II: Principle Office

The principle place of business of the corporation shall be 1610 W 16th Street, Riviera Beach, FL 33404.

Article III: Purpose

The purpose for which the corporation is organized is to build up a spiritual body of Christian believers who worship God and bring other individuals into a personal relationship with Jesus Christ through the proclamation of the good news of the gospel of Jesus Christ as the mean of salvation for all who believe. It is our further desire to extend our hands into fellowship with others of like faith locally and internationally, promote Christian piety, empowering leaders into our communities with the Bible as our sole authority for guidance in living the Christian life. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The period of this corporation is perpetual unless dissolved according to law.

Article IV: Manner of Election

The initial board of directors shall consist of at least three (3) members. The number of directors may be either increased or diminished from time to time based upon the majority vote of the members of the corporation, but the number of Directors shall never be less then three (3) nor more then seven (7).

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of the statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporations exempt from federal income tax under section (501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.

Article VII: Dissolution

Upon the Dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, of the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
