ARTICLES OF INCORPORATION
OF
MASCI GENERAL CONTRACTOR, INC.

The undersigned, acting as incorporator of MASCI GENERAL CONTRACTOR, INC. under Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is of MASCI GENERAL CONTRACTOR, INC. (the "Corporation").
