



**INSTRUCTIONS FOR INCORPORATING
ARTICLES OF INCORPORATION
OF
DEBORAH A. BELFORD, P.A.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is **DEBORAH A. BELFORD, P.A.**

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The corporation is formed to provide real estate service(s) and to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.


ARTICLE VIII
