

ARTICLES OF ORGANIZATION OF WYNWOOD REAL ESTATE, LLC



The undersigned hereby makes, subscribes, and files these Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Expility Company Act:

- Name. The name of the limited liability company is WYNWOOD REAL ESTATE, LLC
- 2. Duration. The period of duration of the limited liability company is perpetual.

The remaining Members of the limited liability company will have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event, which terminates the continued membership of a Member in this limited liability company. No Member shall be entitled to receive a return of capital or other distribution upon withdrawal from this limited liability company or otherwise, except as otherwise provided in the Regulations of this limited liability company.
