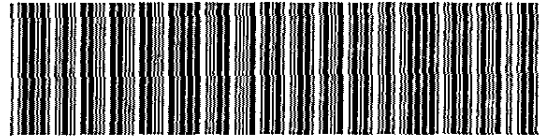

ARTICLE I

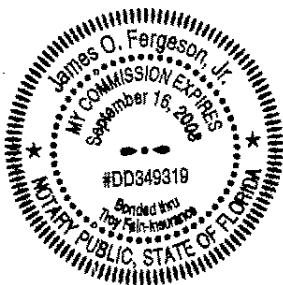
