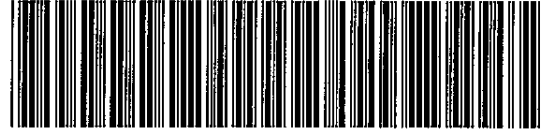

**ARTICLES OF ORGANIZATION
OF

**ARTICLE I

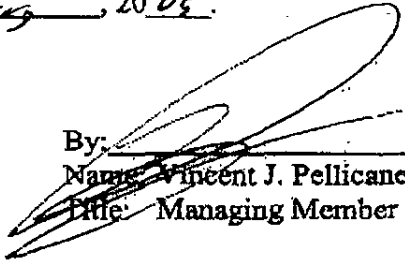
**ARTICLE VII

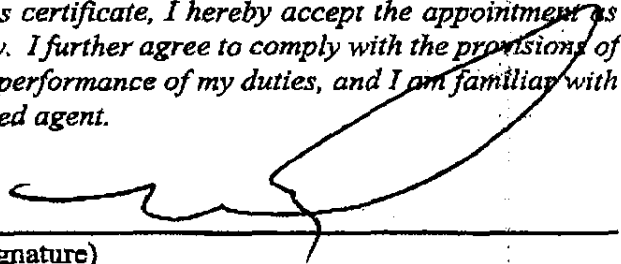
