The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is Naples Investigations, Inc., and the street address of the Corporation is 700 Diamond Circle, #6, Naples, Florida 34110-2403.
