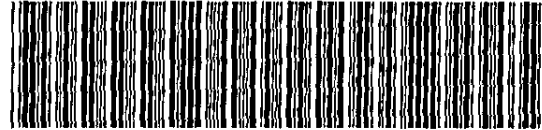

**ARTICLES OF ORGANIZATION
OF
STRAY MUTTS, L.L.C.**

These Articles of Organization are made and acknowledged by the undersigned Members for the purpose of creating a domestic limited liability company in accordance with §608.407 Florida Statutes.

ARTICLE I

The corporate name of the limited liability company shall be **STRAY MUTTS, L.L.C.** The limited liability company is organized to engage in any lawful act or activity for which a limited liability company may be organized under the provisions of the Florida Limited Liability Company Act set forth in Chapter 608 Florida Statutes. Without limitation of the foregoing, it is anticipated that the initial business of the limited liability company will be real property investment.

ARTICLE II

The limited liability company shall have perpetual existence, which existence shall commence upon the date these Articles of Organization are signed by the Members, as indicated below.

ARTICLE III

ARTICLE IV

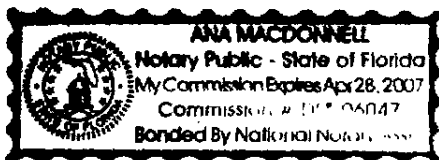


