ARTICLES OF INCORPORATION

OF

The undersigned, being of legal age and competent to contract, for the purpose of organizing a non-profit corporation pursuant to the laws of the State of Florida, do hereby state the Articles of Incorporation of WE CARE BRIDGING GAPS, INC., in their entirety, and adopt the following Articles of Incorporation and agree and certify as follows:

ARTICLE I NAME

WE CARE BRIDGING GAPS, INC.

(Hereinafter a non-profit corporation)

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The property and assets of this corporation are irrevocably dedicated to Charitable, Educational and Literary purposes.

ARTICLE III PURPOSE

The purpose of We Care Bridging Gaps, Incorporation, is to form in the interest and intention, and to introduce into an existing structure, an association of individuals with the intention of providing assistance for the poor, underprivileged, the sick and shut-in people who are in need of support and help. The organization is organized exclusively for charitable purposes. The incorporation shall receive donations and contributions for the purpose of benevolent assistance to the elderly and poor. The organization will attempt to provide a source of financial help to those in need, as well as provide gifts and food.
