Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of
HARNEY MANUFACTURING COMPANY are hereby amended as follows:

FIRST: Article I of said Articles of Incorporation is amended by deleting the
provisions of said Article I as the same now exists, and by substituting in lieu thereof, the
following:

"ARTICLE I


NAME

The name of this Corporation shall be **HARNEY HARDWARE, INC.** and its
principal place of business shall be located at 9610 Harney Road, Thonotosassa, Florida
33592."
