**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

**ARTICLE I**

**NAME**

The name of the limited liability company shall 1159 South Main Street, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 5220 NW 5<sup>th</sup> Street, Bell, Florida 32619.

**ARTICLE II**

**DURATION**

## ARTICLE VII

### TERMINATION OF EXISTENCE



The managers shall be elected in the manner set forth in the Operating Agreement of the Company. 
