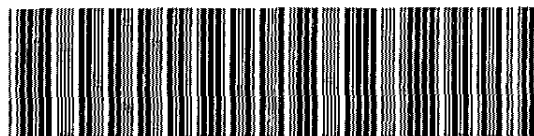

## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)  
**FOR**

**THE CENTRAL TRUTH MINISTRIES, INC.**

Upon recommendation from the pastor, and consent of the Board of Trustees the church membership accepts with unanimous consent the undersigned, acting as authorized representatives of a corporation pursuant to chapter 617, Florida Statutes, adopt (s) the following Articles of Incorporation.

### **ARTICLE I - NAME**

The name of the corporation shall be: THE CENTRAL TRUTH MINISTRIES, INC.

### **ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principle place of business and the mailing address of this corporation shall be:

### **ARTICLE III - PURPOSE**

The specific purpose for which the corporation is organized:

The corporation is organized exclusively as a ministry for one or more of the purposes as specified in section 501 (c ) 3 of the Internal Revenue Code, including but not limited to preaching the (Gospel of Jesus Christ) to the lost souls in the local, city, state, national and international communities, and to promote the teaching of (Authorized King James Version) of the Bible and honor its founder and pastor, Christ Jesus.

### **ARTICLE IV - MANNER OF ELECTION OF DIRECTORS**

**ARTICLE VI - LIMITATION OF CORPORATE POWERS**

The corporation powers of this corporation are as provided in section 617.0302, Florida Statutes, unless as follows: And as prescribed in Section 501 (c ) 3 of the Internal Revenue Code.

**ARTICLE - VII MEMBERSHIP PROVISIONS**

The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows: The membership provisions of this corporation shall be stated in the Bylaws of this corporation.

**ARTICLE VIII - LIMITATION ON POLITICAL ACTIVITIES**

No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation except as otherwise provided by Section 501 (h) of the Internal Revenue Code. This corporation shall not participate in or intervene in (including the publishing or distribution of statements,) for any political campaign on behalf of, or in opposition to, any candidate for public office.

#### **ARTICLE IX - USE OF INCOME**

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in these Articles.

#### **ARTICLE X - GENERAL LIMITATION ON NONPROFIT ACTIVITIES**

Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c ) (3) of the Internal Revenue Code of (2) by a corporation contributions to which are deductible under Section 170 ( c ) (2) of the Internal Revenue Code.

#### **ARTICLE XI - DISSOLUTION PROVISION**

Upon the dissolution of this corporation, its assets remaining after payment or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c ) (3) of the Internal Revenue Code.
