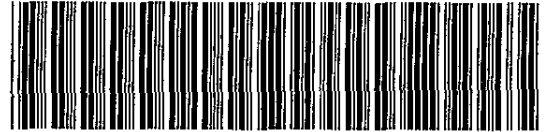

**ARTICLES OF INCORPORATION  
OF  
CE DE ON, INC.**

The undersigned person hereby states the following in order to form a corporation pursuant to the Florida Business Corporation Act:

1. The name of this corporation shall be CE DE ON, INC.
2. The principal registered office of this corporation and the mailing address shall be 7111 Blue Angel Parkway, Apt. 8204, Pensacola, FL, 32526, and the name of the registered agent of this corporation at that address is Holly K. Dear.
3. The corporation is authorized to issue 10,000 shares of stock and each share shall have a par value of One Dollar (\$1.00).
4. The name and address of the Incorporator is Holly K. Dear, 7111 Blue Angel Parkway, Apt. 8204, Pensacola, FL, 32526.
5. This corporation shall exist perpetually.
6. The nature of the business of the corporation and the object or purposes proposed to be transacted, promoted or carried on by it are as follows:
  - a. The primary purpose of the corporation shall be to own and operate a beauty and hair salon;
  - b. To conduct any other business enterprise not contrary to law; and,
  - c. To exercise all of the powers enumerated in Chapter 607 and 621 of the Florida Statutes.
7. The President and Secretary of the corporation shall have the authority on behalf of the corporation to enter into any contract between the corporation and all of its

shareholders (a) imposing restrictions on the future transfer (whether inter vivos, by inheritance or testamentary gift), hypothecation or other disposition of its shares; (b) granting purchase options to the corporation or its shareholders; or (c) requiring the corporation or its shareholders to purchase such shares upon stated contingencies.
