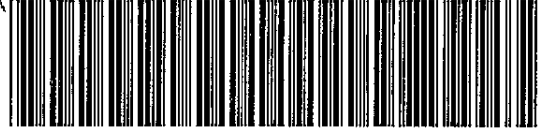

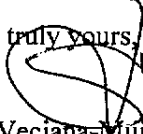

This Limited Liability Company shall have a perpetual existence, commencing on the date of the filing of these Articles by the Department of State.

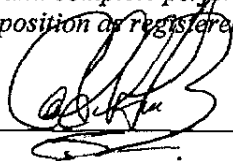
