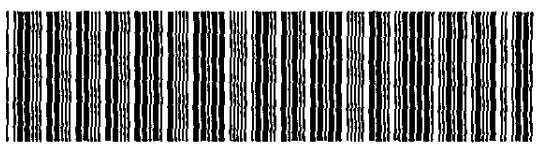

The name of the corporation is CLEVELAND PAIN MANAGEMENT & DIAGNOSTIC, INC.


