ARTICLES OF INCORPORATION OF PALACE PIZZA RESTAURANT, INC.

FIRST: The name of this corporation is PALACE PIZZA RESTAURANT, INC. SECOND: The general nature of the business to be transacted by this corporation, together with and in addition to those powers conferred by the laws of Florida and the United States of American and the principles of common law upon corporations organized under and by virtue of the laws of Florida and the United States of American and the principles of common law upon corporations organized under and by virtue of the laws of Florida is the following, viz:

To engage in preparing and selling food and food products.
