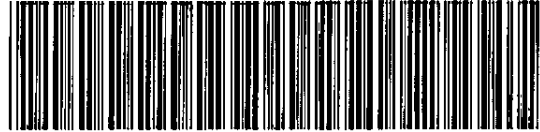

The name of the limited liability company is 3555 Fiscal Court, LLC.


Article II - Address
