## ARTICLES OF ORGANIZATION

#### NAPLES TRUST PROPERTY IV, LLC

A STATE OF THE STA The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

#### ARTICLE I. NAME
