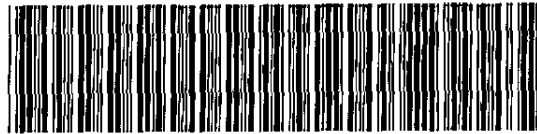

The undersigned initial members of 4560 POINCIANA, L.L.C. a Florida limited liability company formed hereunder (the "Company"), hereby form a limited liability company under the laws of the State of Florida.

ARTICLE I. COMPANY NAME

ARTICLE VII. RIGHT OF ASSIGNEE TO BECOME A MEMBER


ARTICLE XII. AMENDMENT OF REGULATIONS


