ARTICLES OF ORGANIZATION OF FEP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be FEP, LLC (the "Company").

ARTICLE II -- ADDRESS

The mailing address of the Company shall be 11250 Mahogany Run, Ft. Myers, Florida 33913. The street address of the initial principal office of the Company shall be 11250 Mahogany Run, Ft. Myers, Florida 33913.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.
