ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

Name

The name of the limited liability company shall be 4048 Properties, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 4048 Herschel Street, Jacksonville, Florida 32205.

ARTICLE II

Purposes and Powers

ARTICLE VI**Termination of Existence**
