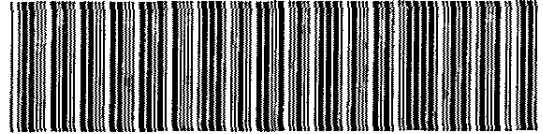

## Articles of Incorporation

### Southwest Florida Aquatics Foundation, Inc.

#### ARTICLE I

The name of this corporation shall be SOUTHWEST FLORIDA AQUATICS FOUNDATION, INC. The principal office and mailing address shall be located at 2918 Lone Pine Lane, Naples, in Collier County, Florida 34119.

#### ARTICLE II

The purpose of this corporation shall be as follows:

To promote aquatic programs throughout the State of Florida.

#### ARTICLE III

The Board of Directors shall consist of not fewer than three (3) persons, the exact number to be determined from time to time in accordance with the By-laws, said By-laws to be adopted by the Directors within six (6) months of approval of these Articles. The initial Directors shall be as follows:

The initial incorporator shall be Charles Slaght, 2918 Lone Pine Lane, Naples, FL 34119.

#### ARTICLE V

This corporation shall have all the powers and authority granted to it under Chapter 617, *Florida Statutes*.

#### ARTICLE VI

The registered agent for this corporation shall be Betty Lou Tucker, and the registered office shall be 4151 Gulf Shore Blvd., #405, Naples, FL 34103.

#### ARTICLE VII

In the event of dissolution, the residual assets of the corporation shall be transferred to one or more organizations which themselves are exempt as organizations under § 501(c)3 of the Internal Revenue Code or corresponding section(s) of any prior or future Internal Revenue Code. Further, it is the desire of the corporation that such assets be distributed to those organizations which have substantially similar purposes as those of Southwest Florida Aquatics Foundation, Inc.


#### ARTICLE VIII

Southwest Florida Aquatics Foundation, Inc. is organized exclusively for charitable, educational and/or scientific purposes under § 501(c)3 of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, Southwest Florida Aquatics Foundation, Inc. shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under § 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under § 170(c)2 of the Internal Revenue Code, or corresponding section of any future federal tax code.
