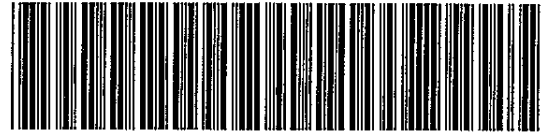



NAME**
