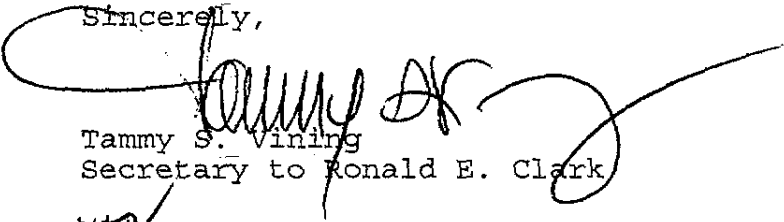

ARTICLES OF ORGANIZATION

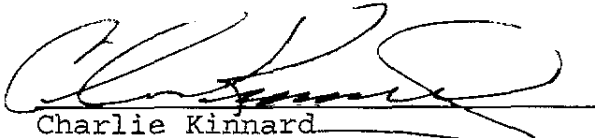

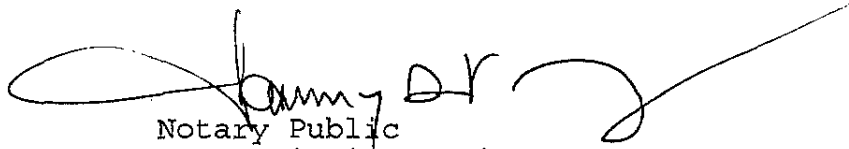

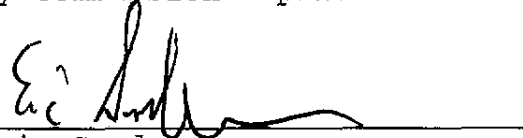
