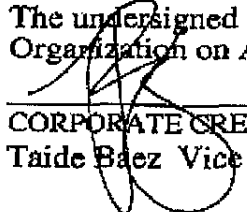
Article VI. Management

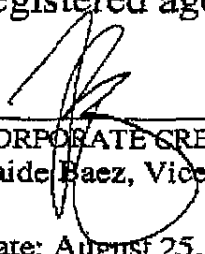
