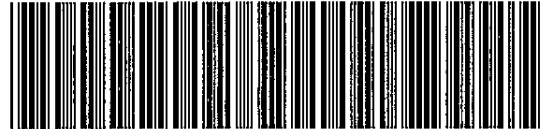

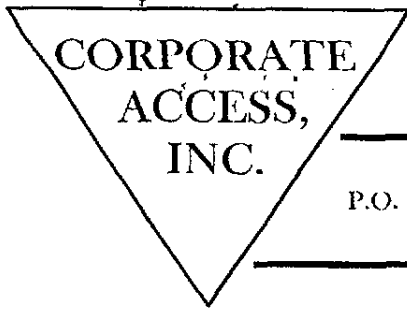


ARTICLE IV — MANAGEMENT
