Articles of Incorporation of

Albert DelloRusso Jr. Memorial Foundation, Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to hold annual and/or semi-annual fundraisers for various causes such as cancer, AIDS, etc. Hurricane Katrina Relief will be the first.
