OF

ARTICLE I - NAME

The name of this Corporation is BLAKE & COMPANY, INC. (the "Corporation").

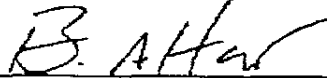

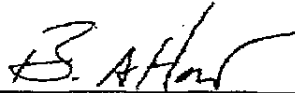
