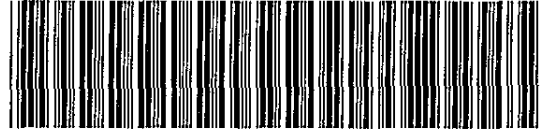

**ARTICLE I – Name No change**

**Amend ARTICLE II to read as follows:**

ARTICLE II -- Not For Profit

The Corporation is a non-profit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary gain. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors, or Officers, except to the extent permissible under law.

**Amend ARTICLE III to read as follows:**

ARTICLE III – Principal Office and Mailing Address of the Corporation

The address of the principal office of the Corporation is, Martin Jones, 4868 Southwind Dr., Mulberry, Fl. 33860, and its mailing address is the same.

**Amend ARTICLE IV to read as follows:**

ARTICLE IV – Commencement and Duration

The Corporation is to commence its corporate existence effective upon the filing hereof, and shall exist perpetually thereafter until dissolved according to law.

**Amend ARTICLE V to read as follows:**

ARTICLE V – Purposes

The purposes of the corporation are to unite the airport easement holders for the preservation of the South Lakeland Airport, to provide a venue for an exchange of ideas and to cooperate with the runway and taxiway owners in the use and improvement of the airport, and to preserve, maintain, and protect the various rights of the Members in and to the South Lakeland Airport, and its runways and taxiways.

To perform the functions of the Southwind Homeowners Association per the agreement between the airport owner and the various airport easement holders as recorded in Polk County Public Records book 3247, pages 0617, 0618, 0619, 0620, 0621, and the Southwind Homeowners Association as referred to in the Amended Final Judgment of the Circuit Court of the Tenth Judicial Circuit in Polk County, Case numbers GCG-85-703, GCG-82-637, GCG-82-771 as recorded in Polk County Public Records Book 2592, pages 0845, 0846, 0847, 0848, 0849, 0850. And to assume the obligations of the expense of easement assignment use, maintenance, mowing, licensing, and general upkeep of the easement if the airport owner voluntarily or involuntarily fails to perform his obligations to perform those duties.

If it becomes necessary for the corporation to assume the obligations of airport easement maintenance and to collect the annual airport easement fees, those fees will not be assessments or mandatory fees, but payment of fees mandated by the easement grantor and voluntarily assumed when the easement was granted. Should it become necessary for the corporation to assume the obligations of airport easement maintenance, it will also assume responsibility of billing for and collecting all easement fees, which will be paid to the corporation, to be used for runway and taxiway maintenance, whether or not the easement holders are members of the corporation.

**Amend ARTICLE VI to read as follows:**

**ARTICLE VI – Limitations**

The corporation shall never be empowered to make any assessments or collect other monies from its members which are not voluntarily paid. The corporation shall never be empowered to interfere in or control any aspect of any homeowner as to the use, appearance, upkeep, or maintenance of the homeowner's private personal or real property.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its Members, Directors, or Officers, but the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes.

**Amend ARTICLE VII to read as follows:**

**ARTICLE VII --Board of Directors**

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the Corporation shall be managed under the direction of the Board of Directors. The Corporation shall have three (3) directors initially. The number of Directors may thereafter be increased or decreased from time to time in accordance with the by-laws of the Corporation, but shall never number less than three (3). The names and street addresses of the directors who shall hold office until their successors, who shall be chosen at the first meeting of the members have qualified, shall be:

**Amend ARTICLE VIII to read as follows:**

**ARTICLE VIII – Members**

Membership in the corporation is voluntary and is limited to those persons who own property at South Lakeland Airport. Determination of eligibility is to be made by the members, at their sole discretion. The Corporation shall have voting members who shall be elected and may be removed by the voting members and shall have all the rights and privileges of members of the corporation.

Each member shall have one vote on matters coming before the Corporation. No entity may own more than one membership nor control more than one vote.

An initiation fee of \$25.00 and annual dues of \$25.00 must be paid by each member for the first year of membership. Thereafter, the annual dues shall be \$25.00 per year.

**Add ARTICLE IX**

**ARTICLE IX By-Laws**

The power to adopt, amend, or repeal by-laws shall be vested in the Board of Directors and the Members, but the Board of Directors may not alter, amend, or repeal any by-laws adopted by the Members if the Members provide that the by-laws shall not be altered, amended, or repealed by the Board of Directors.

**Add ARTICLE X**

**ARTICLE X – Officers**

The Officers of The Corporation shall consist of a President, Vice President and Secretary/Treasurer and such other Officers and Assistant Officers as may be provided in the By-laws. Each Officer shall be elected by the members, and may be removed by the members, at such time and in such manner as may be prescribed by the By-laws.
