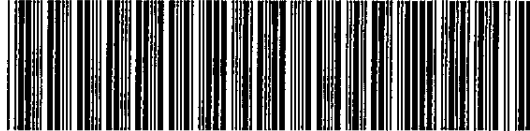

The undersigned makes the following declaration of information for the purpose of forming RFP Asset Management, LLLP under the Florida Revised Uniform Partnership Act: RFP Asset Management, LLLP

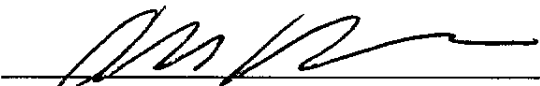

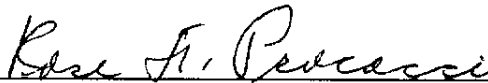
