I started experiencing mild depressive episodes in the early 90's. My primary physician, Valerio Toyos, would prescribe anti depressants during these occurrences. In the late 90's these episodes became more frequent and more severe and started interfering with my work performance and my ability to generate income. Being a Real Estate Broker, a field that primarily requires sales, my abilities were greatly diminished during these episodes.

My reduced income created problems in my personal life. My illness was not accepted as such, by my spouse, who felt I was no longer the person she married. In early 2001, I was diagnosed as severely clinically depressed by a psychiatrist to whom my primary physician had referred me to. I started on therapy and continued the antidepressants, but this diagnosis led to my divorce effective in 2002.

I am still under treatment for depression and take anti depressants. What small income I have been able to generate has been mainly through the help of friends in the industry and clients that had known me well from before.

I have been able to subsist through the help of my mother, who has provided me with support since 2001. I am actively working on my recovery and with God's help should be functional at some point in the near future.

I am making a concerted effort to straighten out all of the negative issues in my life. I often feel that only someone that has experienced a deep depression can realize the effort it takes to try to overcome all adverse situations and get back on a positive constructive track.
