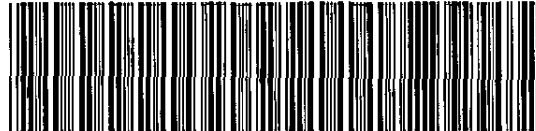

The Company is to be managed by one or more managers and is,


