

ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF AUGUST LINKS CONDOMINIUM ASSOCIATION, INC.

The undersigned, certifies that:

- 1. She is the President of August Links Condominium Association, Inc., a Florida corporation, whose Articles of Incorporation were filed originally with the Secretary of State, State of Florida, on April 18, 2005, and Amended and Restated on September 23, 2005.
- 2. The following amendment to the Amended and Restated Articles of Incorporation was adopted and approved by the sole Member, by written consent in lieu of a meeting, dated December 8, 2005. The number of votes cast for the amendment was sufficient for approval.
