

to pay reasonable compensation for services rendered and to make payments, emoluments and/or distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of this organization shall be then the carrying on of propaganda, or otherwise attempting to influence legislation whether local, state or federal, and this organization shall not participate in, or intervene in (including the publishing or distribution of official statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, this organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income taxation under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code, or the Internal Revenue Code, or any corresponding section of any future federal tax code.

Third Amendment - Upon the dissolution of this organization, assets shall be distributed for one or more tax exempt purposes within the meaning of section 501 ©(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a local or state government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas in Collier County, Florida, in which the principal office of the organization is currently located, or by the Court of Common Pleas of the county in which the principal office of this organization shall be located at the time of dissolution. This disposition of assets will be done exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Fourth Amendment – The amendments approved by the executive board of directors of JERUSALEM HAITIAN COMMUNITY CENTER, Inc. in executive session on December the twenty-third, in the year 2005, will be considered as applicable and enforceable on January the first, 2006. No amendment can be introduced in future that in any way contravenes or nullifies the provisos of the four amendments hereby introduced in the Articles of Incorporation of JERUSALEM HAITIAN COMMUNITY CENTER, Inc.
