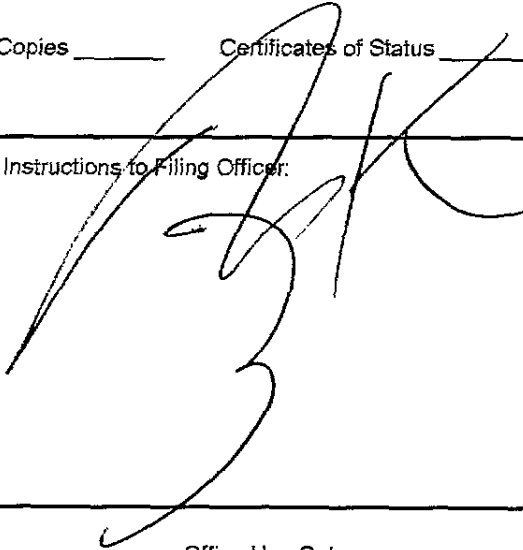

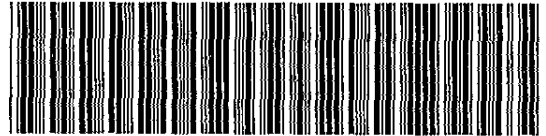

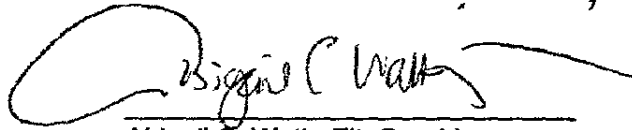
**ARTICLE VI


