ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF AUGUST LINKS CONDOMINIUM ASSOCIATION, INC.

The undersigned, certifies that:

- She is the President of August Links Condominium Association, Inc., a Florida corporation, whose Articles of Incorporation were filed originally with the Secretary of State, State of Florida, on April 18, 2005, as amended.
