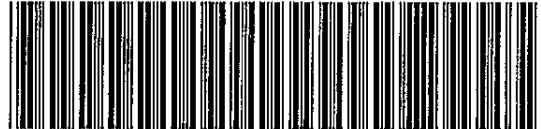

## ARTICLES OF INCORPORATION CR Custom Works, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the state of Florida.

### ARTICLE I- NAME

The name of this corporation is CR Custom Works, Inc.

### ARTICLE II- DURATION

- This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.


