

To Whom it May Concern:

Please find enclosed with this letter the necessary forms and documentation to amend the certification for "The Bank" as a foreign profit corporation doing business in Florida. Because the transaction leading up to this amendment is not common, this letter is intended to serve as a brief explanation of what occurred. In 2005, The Bank was acquired by a new owner. At that time, The Bank was a state-chartered bank doing business under the laws of Alabama. In late October of that year, The Bank converted from a state-chartered bank into a federal savings bank. This change means that it is no longer an Alabama business regulated by the State of Alabama. Instead, it is now a federally-chartered business subject to regulation by federal banking authorities. And finally, effective January 1, 2006, The Bank changed its name to Superior Bank.

In short, The Bank, an Alabama-regulated bank, is now Superior Bank, a federally chartered savings bank.

To Whom It May Concern:

Please be advised that in October of 2005, The Bank, an Alabama-chartered bank with offices in Alabama and Florida, converted to a federal savings bank through its merger with a newly established interim federal savings bank also with the name The Bank. As a result of this conversion, The Bank relinquished its Alabama state charter and became subject to the supervision and regulation of the Office of Thrift Supervision ("OTS"), a division of the U.S. Department of the Treasury. Finally, effective January 1, 2006, The Bank changed its name to Superior Bank.

In short, The Bank, formerly an Alabama-chartered bank, is now Superior Bank, a federally chartered savings bank, subject to the supervision and regulation of the OTS. Inquiries for the OTS concerning Superior Bank should be directed to P.O. Box 105217, Atlanta, GA 30348-5217.
