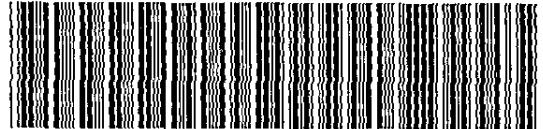



DESIGNATION OF VICE PRESIDENT


