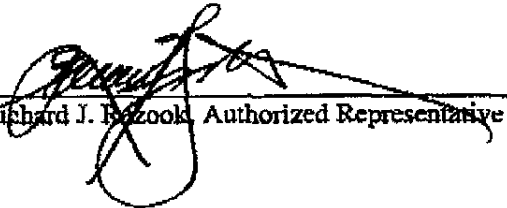
**VII. ADMISSION OF ADDITIONAL MEMBERS**
