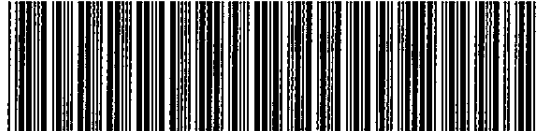

- b. Pursue its purposes and business in any and all locations, foreign or domestic.
