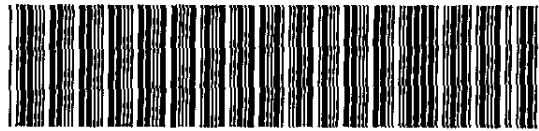

ARTICLES OF ORGANIZATION
OF

The undersigned, intending to form and create a Limited Liability Company, as defined in §608.401, *et seq.*, the Florida Limited Liability Company Act, hereby states and certifies the following:

ARTICLE I - NAME

ARTICLE VI


CERTIFICATE OF LIMITED LIABILITY
