ARTICLES OF ORGANIZATION OF GO BAHAMAS, LLC,

a Florida Limited Liability Company



The undersigned, being the initial member of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

ARTICLE I

The name of the limited liability company shall be **GO BAHAMAS**, **LLC**, a Florida limited liability company (the "Company").

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall be 100 Aviation Drive South, Suite 203, Naples, Florida 34104.

ARTICLE V EFFECTIVE DATE

The Company's effective date of existence shall begin on the date of filing of these Articles.

ARTICLE VI DURATION

The Company's duration shall be perpetual. Ray, until such time as the Members designate, appoint or elect a successor or substitute manager in accordance with the terms of the Operating Agreement and Regulations of the Company. The number of managers may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations.
