The mailing address and street address of the principal office of the Limited Liability Company is 1146 Skye Lane, Palm Harbor, FL 34683.

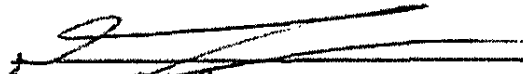

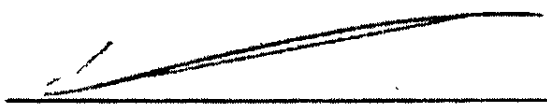
