The initial mailing address and street address of the principal office of the Company shall be 5099 Castlerock Way, Naples, Florida 34112.

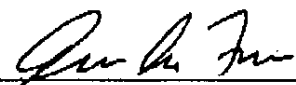
ARTICLE III - REGISTERED AGENT & REGISTERED OFFICE

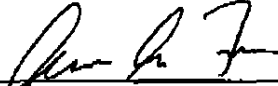
