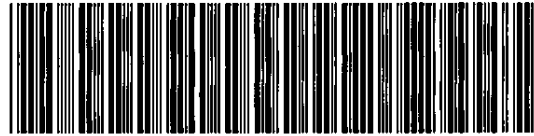

The name of the Limited Liability Company is AA HIALEAH 80, LLC (the "Company").


