

Pursuant to the provisions of section 617.1006, Florida Statutes this Florida Not for Profit Corporation adopts the following articles of amendments to its Articles of Incorporation:

FIRST: Amendments adopted:

**ARTICLE I (C)**

The principal office of the Corporation will be located at 5555 Biscayne Blvd., Miami, Florida 33137.

**ARTICLE I (D)**

The registered agent of the Corporation is David Slachter, whose address is 14830 Dade Pine Ave., Miami Lakes, FL 33014.

**ARTICLE IV**

The membership of this Corporation shall be limited to past or present Directors of the ASSOCIATION FOR RETARDED CITIZENS, SOUTH FLORIDA, INC., a Florida non-profit corporation.

The number of Directors of the Corporation shall be at least four (4) in number and shall be elected by the members of the Corporation from the membership. The Directors of the Corporation must at all times be members of the Corporation. No non-member of the Corporation may sit as a Director. The Directors shall serve without compensation.

The annual meeting shall be held during the first week of June of each year.


