ARTICLES OF ORGANIZATION OF FLOORS BY BERT, LLC

The undersigned hereby forms a limited liability company with the meaning of the applicable provision of Chapter 608, Florida Statutes.

ARTICLE I

The name of this limited liability company is FLOORS BY BERT, LLC (the "Company").

ARTICLE II DURATION
