ARTICLES OF ORGANIZATION FOR

## GOLD KROWN FARMS, LLC (A Florida Limited Liability Company)

#### ARTICLE I - Name:

The name of the Limited Liability Company is GOLD KROWN FARMS, LLC.

#### ARTICLE II - Address:
